Dogs Eligible to Enter

This trial is open to all dogs six (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number, or are approved Foundation Stock Service (FSS) breeds.

Dogs with a PAL/ILP number or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Dogs should be physically sound. Dogs that are blind, bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance are not eligible to compete. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Rules Applying to Registration and Discipline for the listing of registerable breeds that may participate.

Wherever the word "dog" is used in these regulations, it includes both sexes.

Class Running Order

Rally Trials 1 & 2 will run concurrently as follows.

Obedience Trials 1 & 2 will run concurrently. The final schedule will not be set until entries close and individual class counts are available. Open A/B/Preferred and Utility A/B/Preferred will be scheduled in the morning and Novice A/B/Preferred and optional titling classes will be scheduled in the afternoon **if possible, based on the entry**.

Notice to Exhibitors

- The <u>safety of the dogs</u> is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all exercises safely.
- Mound City Obedience Training Club may cancel this event in extreme weather conditions.
- Entry fees will not be refunded if the trials cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.
- Since <u>bitches in season</u> are not allowed to compete in AKC Obedience or Rally Trials, the club will refund all but \$5.00 of the entry fee per day for bitches unable to compete for that reason. The Trial Secretary must receive <u>written notification</u> from a veterinarian of such a claim for refund by letter hand-delivered, emailed, or postmarked before the trial commences.
- The club will refund all but \$10.00 of the entry fee per trial for injured dogs or handlers. Written request for a refund must be made to the Trial Secretary prior to the start of the first trial day and a veterinarian's or doctor's letter must be provided within one week of the trial.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.
- Exhibitors are responsible for being ready for judging when called to the ring. The judge need not wait for any dog holding up a class. Mound City Obedience Training Club has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.
- Entries must be made on Official AKC entry forms or copies and <u>must include the signed</u>
 <u>Agreement and Rules</u>. <u>Junior Handlers</u> must complete back of form.
- All owners of mixed breed dogs must first obtain an AKC Canine Partners listing number before they may enter an AKC event. The dog's breed name should be entered as "All American Dog". The dog's listing number must be entered on the entry form and "AKC No." checked.

(Variety) If you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety your are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color); Beagles (not exceeding 13 inches, over 13 in., but not exceeding 15 in.); Dachshunds (longhaired, smooth, wirehaired); Collies (rough, smooth); Bull Terriers (colored, white); Manchester Terriers (standard, toy); Chihuahuas (smooth coat, long coat); English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles); Poodles (toy, miniature, standard).
- 2. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., A or B division.
